Otherwise competitors, ag retailers unite to benefit local communities, employees and the industry through ResponsibleAg.

ften, ag inputs companies don't have much of a reason to proactively join forces. Each is busy operating its business to serve local producers. However, by setting aside their competitive natures and working together through ResponsibleAg, fertilizer manufacturers, wholesalers and ag retail businesses can better their operations and the entire industry.

ResponsibleAg is a way for us to come together as a self-regulated community, for the betterment of the industry as a whole," says
Tim McArdle, Chairman of the ResponsibleAg board and Chief
Operating Officer and Executive Vice President of Brandt Consolidated, Inc.

"Being pro-active and certifying that our facilities are compliant with the hundreds of federal regulations not only improves safety, but also shows we are responsible. Certification also can help prevent more regulations from coming down on us unnecessarily in the future, and that benefits us all," McArdle says.



ResponsibleAg board members were on hand to host officials from EPA, DOT and DHS as agency officials toured the Ford B. West Center for Responsible Agriculture in Owensboro, KY, in October 2018. The tour detailed the industryled initiative, showcasing the facility audit process, ResponsibleAg Certification Program and auditor training.

The ResponsibleAg Certification Program provides a platform to help ag retailers ensure they are compliant and proactively manage safety risks using an assessment process and related training. Participating facilities are audited by a ResponsibleAg-credentialed auditor once every three years. Up to 17 areas of a facility can be assessed to ensure pertinent regulations from OSHA, DOT, EPA and DHS are

being followed. The facility receives a corrective action plan listing issues that were discovered.

Safety important to communities, industry

Brandt is headquartered in central Illinois where anhydrous ammonia is a major source of nitrogen for the company's corn grower customers.

Anhydrous obviously must be handled carefully.

"In our business, work comes all at once in the spring. We must be ready to do a lot of work in a

hurry, while maintaining our compliance and safety practices," McArdle says.
"Even though Brandt took great pride in our facilities doing everything right, when ResponsibleAg was formed, we challenged our facilities to participate. Today, we have 100 percent buy-in of all our locations.

"I believe the number one advantage of our membership in Responsible Ag is the benefit it provides the communities we serve," McArdle says. "Ag retail operations are near where customers, employees and their families live, work and go to school. By improving the safety and regulatory compliance of our facilities we protect our communities and put our industry in a good light."

Employee safety is an investment

In an industry where sales and volume make or break a business, the impact on the bottom line is constantly evaluated. McArdle believes the value of ResponsibleAg certification goes far beyond dollars and sales goals.

"What is the value of knowing when you go to bed at night you've done everything in your power to make sure your employees aren't going to be injured?" asks McArdle. "It's hard to put a number on these things, but we all have a responsibility to make sure products are safely stored and handled and create no unintended environmental hazard. ResponsibleAg is a way to increase our accountability."

Competitors are partners to benefit all

McArdle says one of his biggest takeaways from being on the

the fertilizer industry and keep the ResponsibleAg assessment checklist and online resource library current.
